Angela Murphy called to order the regular quarterly meeting of the Local Emergency Planning Committee (LEPC) on January 14, 2020, at 2:00 p.m., at the Allen County Regional Hospital.

Sherrie Riebel moved minutes of October 8, 2019, be approved as presented. Linda Mulholland seconded. Hearing no disagreement, motion carried.

Doug King, Safety and Health Inspector, with Midwest Fertilizer was introduced and spoke about the fire on January 1, 2020, at Midwest Fertilizer, Iola. Cole Herder, Humboldt City Administrator, and Tim Thyer, Iola Fire/Allen County EMS also spoke about the incident. All complimented Midwest Fertilizer personnel for their urgent, serious, and thorough response to the crisis and the clean up afterward. The City of Humboldt water supply was contaminated due to the run off water used to extinguish the fire. All agencies involved were cooperative and communication was key. Also, the information provided by Midwest Fertilizer in their Tier II report was very helpful and emphasized the importance of any business storing chemical or combustible material turn this in on a Tier II report.

Jason Trego, Allen County Emergency Management, presented the After-Action Review of the exercise held on November 1, 2019. This represents Allen County's 2019 exercise as required. All present agreed with the findings. This report will be submitted to the State.

The Training and Exercise Planning Workshop (TEPW) plan was presented and reviewed. A committee is being formed to begin work on a new exercise with thought it will target a pipeline incident.

Jason Trego reviewed upcoming trainings.

Angela called for any comments, ideas, or suggestions.

Next meeting is scheduled for April 14, 2020.
